Annual General Meeting 2014

7:00 pm, May 7th, 2014

The meeting took place at the Alexander Community Centre, 960 Silver Street, Ottawa.

1) Welcome and introductions

Kevin Waghorn (meeting chair) called the meeting to order and welcomed everyone to the 2014 Annual General Meeting (AGM).

2) Establishment of quorum

Mr. Waghorn asked all CCA members for a show of hands and confirmed establishment of quorum for the AGM.

3) Adoption of the Agenda

One change was adopted to allow Councillor Maria MacRae's report to come earlier in the agenda. Motion: That the agenda be adopted as amended. Moved: Lynn Collins; Seconded: Phil Bartlett \rightarrow **Carried**

4) Approval of the minutes

Annual General Meeting of May 2013 Motion: That the minutes of the 2013 AGM be approved. Moved: David Darwin; Seconded: Robert Crout \rightarrow **Carried**

5) Report from Councillor Maria McRae

City Councillor Maria McRae provided her report on activities in the community noting that it was a longer than usual report (taken as read). Ms. McRae presented certificates of appreciation to the Board of Directors and thanked them for their dedication to the community.

The floor was opened to questions.

- It was asked if the Energy East Pipeline was on the city agenda. Councillor McRae informed the members that this was a federal issue and not under the city's jurisdiction. However, there were two zoning issues that might come up. The planning was regulated by Environment Canada and at present it was not clear where the line would run. Possibly through Stittsville/Richmond but no location requests had been filed. The Ministry would be responsible for any clean-up.
- It was asked if it would be possible to place a crosswalk at the Merivale and Carling island. The city is not permitted to place a crosswalk in a location that is not designated as a formal crossing.
- 3. A member asked about ways of controlling left-hand turns into Carlington off Fisher Ave. The city was monitoring the issue and a complaint was being investigated regarding speeding off of Fisher. Police were monitoring and enforcing laws. City was looking at two possible crosswalks on Fisher, one at Tunis and the other south of Baseline. Funding was needed for the crosswalk.
- It was wondered if the Councillor knew when the Ashcroft development in Central Park would begin. Not certain at this point but the developer had hit their funding target. They would be putting in a central sidewalk area to mitigate traffic on Merivale.

Mr. Waghorn thanked Councillor McRae for her report.

6) Suya Spot Update

The public hearing was scheduled for May 13 and 14, 2014 at the Best Western Hotel on Carling Ave. Attendees would have to sign in by 9:00 am on the 13th. The community was strongly encouraged to attend to demonstrate the importance of the issue.

A motion was required to allow Mr. Waghorn to continue representing the CCA at the hearings as he would not be continuing on as President.

Motion: That Kevin Waghorn remain as the CCA representative at the Suya Spot hearings in his future role as Past President.

Moved: Margerite Dehler; Seconded: Nancy Beleahn \rightarrow **Carried**

7) President's report

Mr. Waghorn provided the President's report, explaining that it had been a difficult year including the loss of a President. The Suya Spot controversy had been a major issue in the community. He also noted that Carlington had developed a great deal in the past few years.

Highlights of the year included:

- ii. The successful yard and plant sale
- iii. The Rain Barrel sale fundraiser
- iv. Greening of the Merivale/Carling triangle with Councillor McRae
- v. Carlington Cup and chili cook off
- vi. Success of the Gowling Parents for EFI movement
- vii. The Family Fun Day which had about 500 attendees in 2014
- viii. New business sponsors including: Bowman's Bar and Grill, Councillor Maria McRae and realitor Angie Zaryski

Motion: To accept the 2014 President's Report as presented. Moved: David Darwin; Seconded: Robert Crout \rightarrow **Carried**

8) Treasurer's report

Linda Dodd presented the Treasurer's Report, outlining the revenues and expenditures for the year. The balance of funds as of April 30, 2014, was \$4,244.03, which was an increase over the previous year's final balance.

Motion: That the Treasurer's Report be received and a copy be attached to the minutes of the meeting. Moved: Robert Crout; Seconded: Lynn Collins \rightarrow **Carried**

Councillor McRae noted that the rental of city properties and insurance for events could be covered by the Councillor's office. She agreed that her office would contribute to events once again this year.
